

# TERMS OF SERVICE

Effective 22-09-2026

These terms apply to every purchase of a Hard Markets product, including **Do not be fast to sell: Complete Edition**. They are sold by Skill to Scale, operated by Nazem Tayara ("we", "us"). Hard Markets is the book and training series published by Skill to Scale. By completing a purchase you agree to these terms, our Privacy Policy and our Return Policy.

## 1. WHO MAY BUY

You must be at least 18 years old and able to enter a binding agreement. If you buy on behalf of a company, you confirm you are authorised to do so.

## 2. WHAT YOU BUY
